## Classes

**Run Order:** Juniors, Puppies, Altered, Intact

**Junior Classes:** Peewee, Sub Junior, Novice & Open, to be divided by ages 8-12 years and 13 - 17 years.

NOTE: Juniors may compete with any breed; however, for ASCA points in the merit programs, the dog must be an Australian Shepherd and must meet ASCA Junior ownership requirements (rule book available at [www.asca.org](http://www.asca.org))

**Conformation Classes:** To be divided by sex

**Non-Regular Puppies:** 2-4 month, 4-6 month

**Altered & Intact:** 6-9 month, 9-12 month, 12-15 month, 15 - 18 month, Novice, American Bred, Bred By Exhibitor, Open Blue Merle, Open Red Merle, Open Black, Open Red, Best of Breed

**Rosettes & Awards to:** BJH, RJH, BOBP, BOSP, AWD, ARWD, AWB, ARWB, ABOW, ABOS, ABOB, WD, RWD, WB, RWB, BOW, BOS, BOB, Select Dog, Select Bitch

## Show Venue

**Hours:** The show site opens at 7:00 am Saturday, February 14 and closes at 6:00 pm on Sunday, February 15.

**Environment:** Grooming will be done outside. Please bring a canopy to groom under as the weather is unpredictable. Generators are permitted. Please be mindful of the direction of your generator exhaust and ventilate away from other exhibitors and their set ups. The building is heated, please provide your own seating. Absolutely NO grooming inside of the building! NO grooming tables, grooming sprays or powders will be allowed in the building. NO EXCEPTIONS! If you have used powders outside, please make sure it is properly blown out of the coat/feet and is not tracked inside the building. Ringside touch ups with a brush are permitted.

**Day Parking:** Parking is adjacent to the show site.


